Updated November 25, 2019. Maryland Law and Regulation on Out of State Vendors. Under Maryland law, a person who engages in the business of an out-of-state vendor must register with the Maryland Comptroller, collect and pay sales and use tax, and file Maryland sales and use tax returns.
