The standard conditions of sale are a set of Law Society produced contract conditions to which the vast majority or residential sale contracts are subject. A solicitor is not obliged to incorporate the standard conditions of sale into any contract he drafts but it is very rare to see a contract which is not subject to them.

Standard Conditions Of Sale (5th Edition)

When buying or selling a residential property, the contract you sign will usually incorporate the Standard Conditions of Sale. At the time of writing the Standard Conditions of Sale are on their 5th edition, which was launched in 2011 by the Law Society. The conditions provide for the terms under which the sale or purchase will operate.
